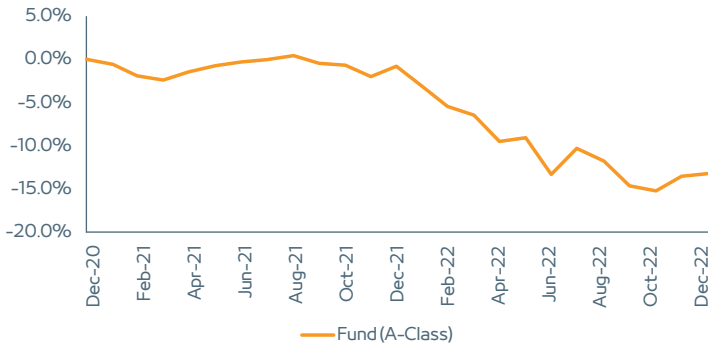

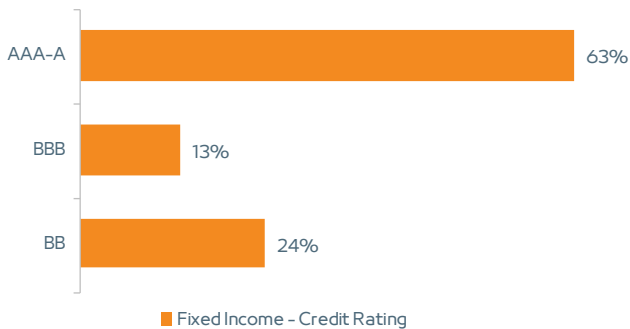

Asset Allocation



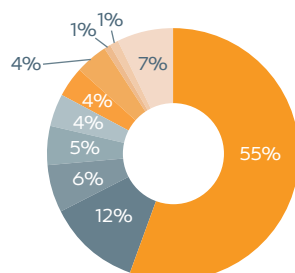

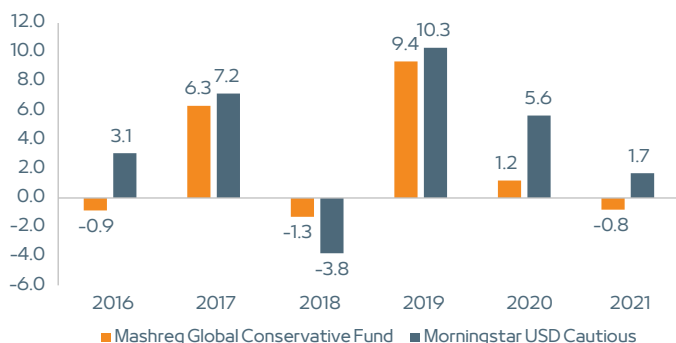

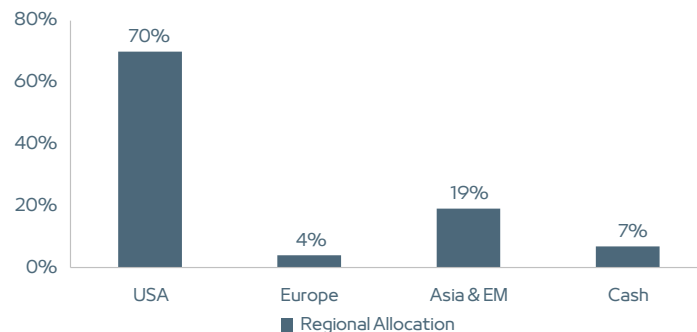
