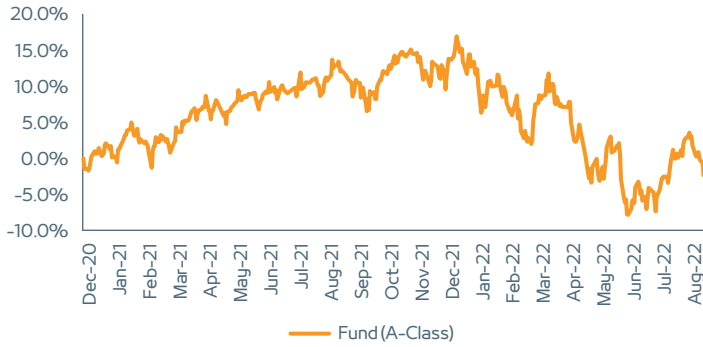

Performance Chart



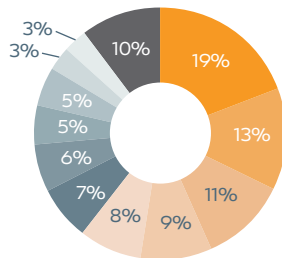

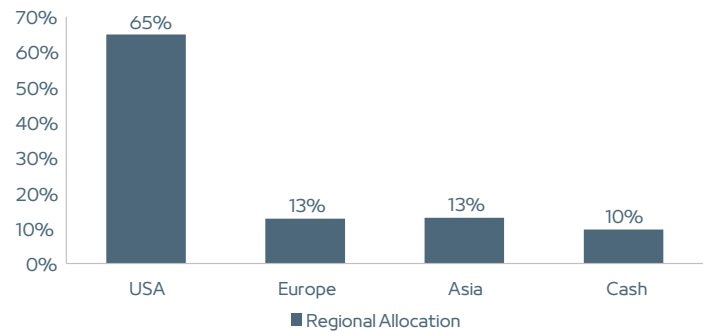

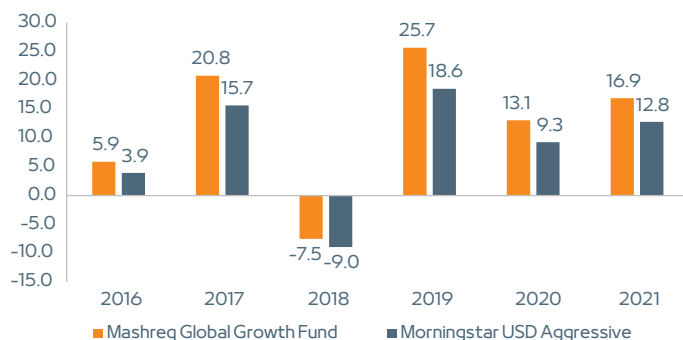
