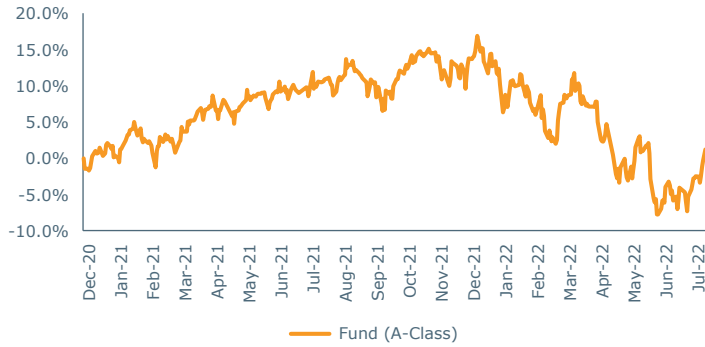

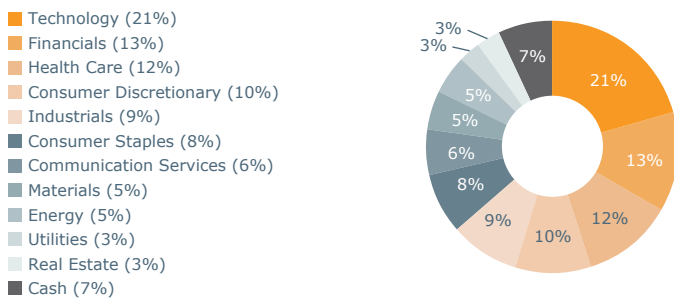

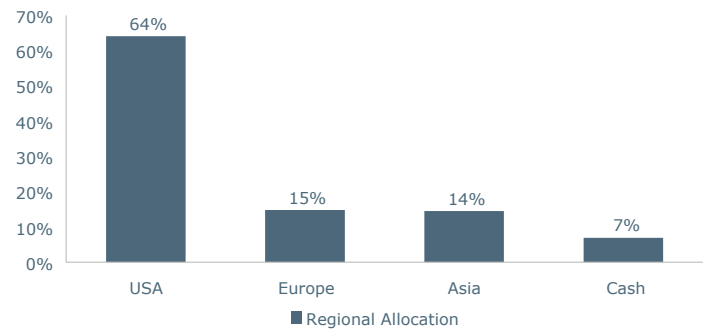
**Asset Allocation**



**Sector Allocation**

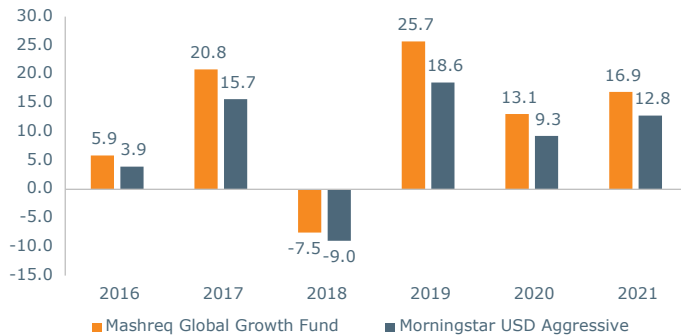
