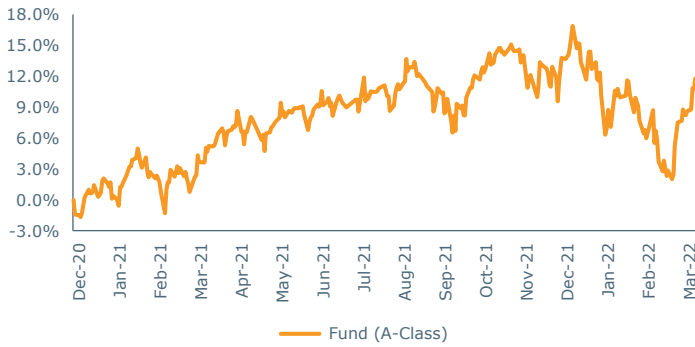

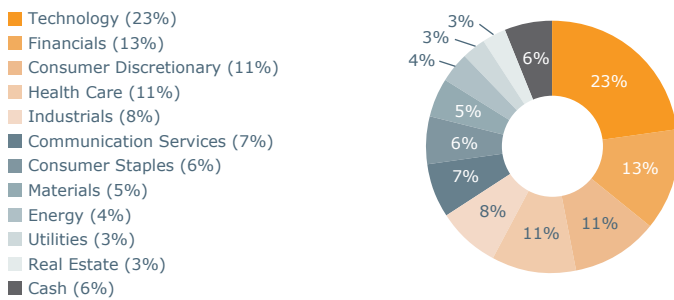

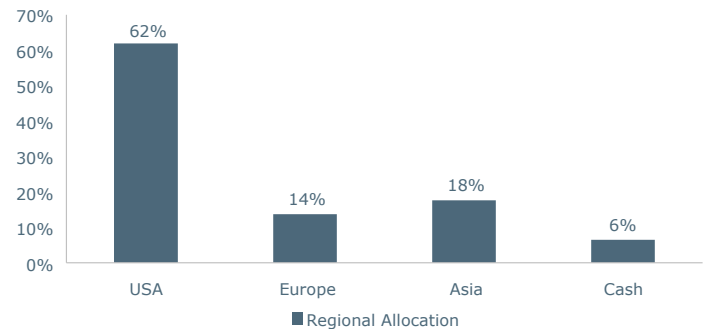
Asset Allocation



Sector Allocation

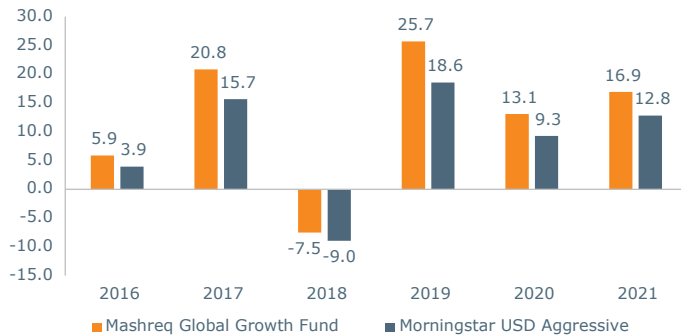


Regional Allocation
