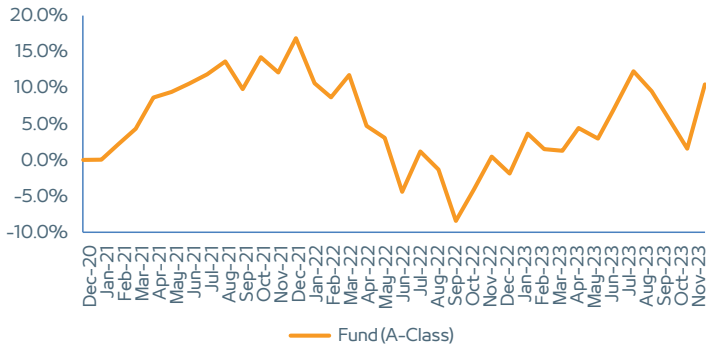

## Performance Chart

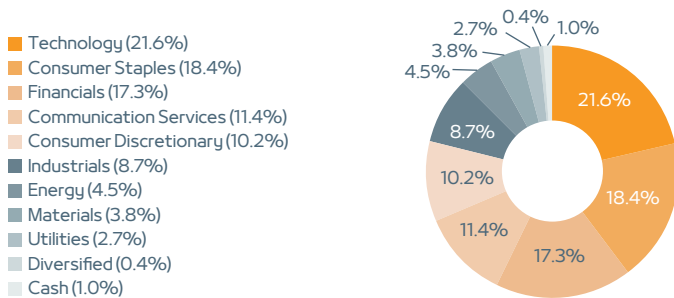

## Sector Allocation



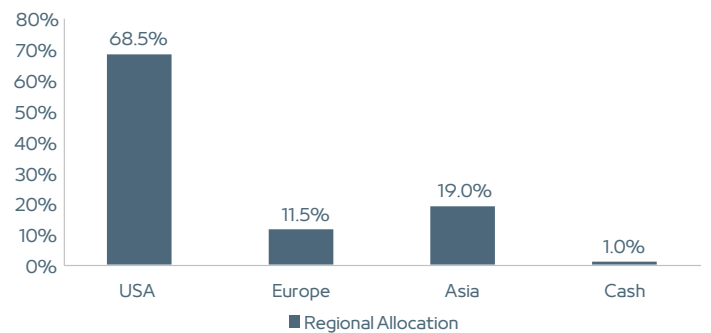

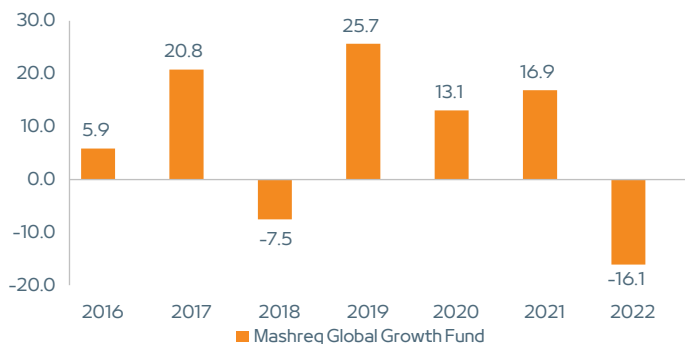
