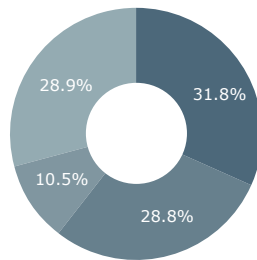

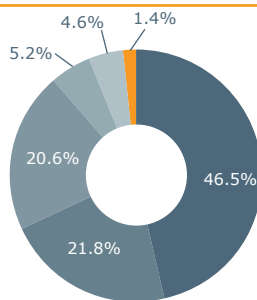
Maturity Profile

- 20+ Years (28.9%)



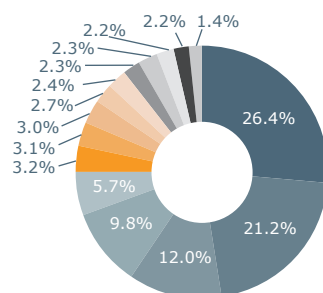
Industry Allocation

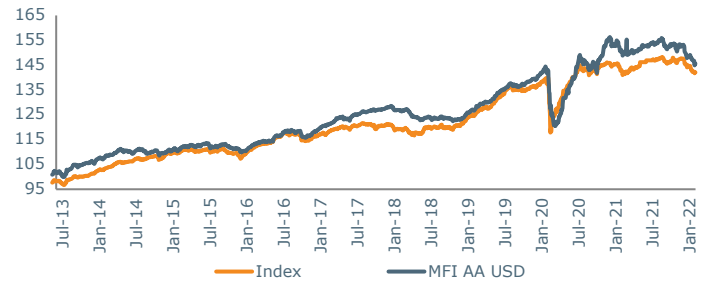
