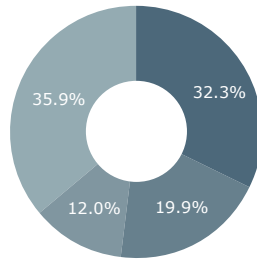

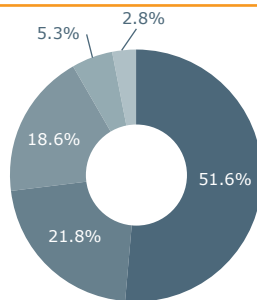
Maturity Profile

- 20+ Years (35.9%)



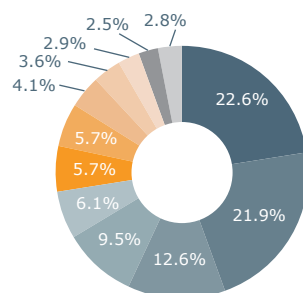
Industry Allocation

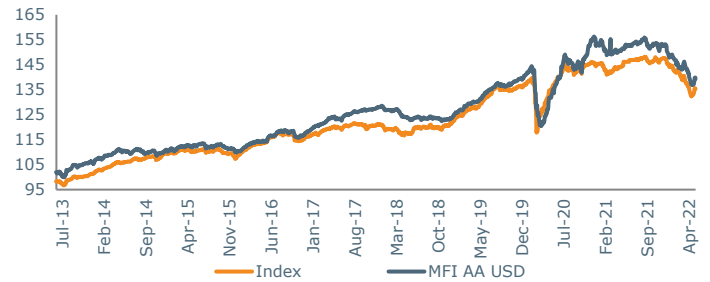
